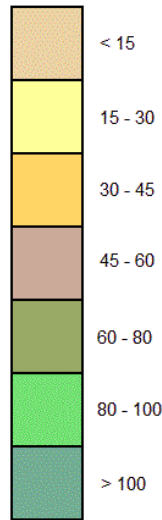

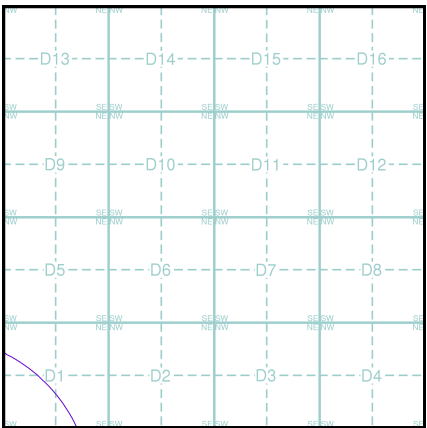

Hi Sophie,

Thank you for the plan showing the area you are interested in.

I can confirm that there are three small discrete areas that are within our Part IIA inspection list within that area. I have attached a plan showing their locations as per our GIS system. From north to south these features are:

- Sewage works
- Above ground tank
- Potentially backfilled pit

At the present time, none of the features are determined as contaminated land under Part IIA of the Environmental Protection Act. However, it will be considered for detailed inspection but no timetable has been set for the inspection to be carried out. Inclusion in our inspection programme does not imply either that the above past use has led to contamination or that any part of the site is contaminated land, as defined. The inspection programme should not be viewed as a list of contaminated land and is held under review by the Council as new information becomes available. Given the current use of the site these features are a low priority for inspection.

We do not have any specific land contamination information at this site in relation to the above features or any other part of the site.

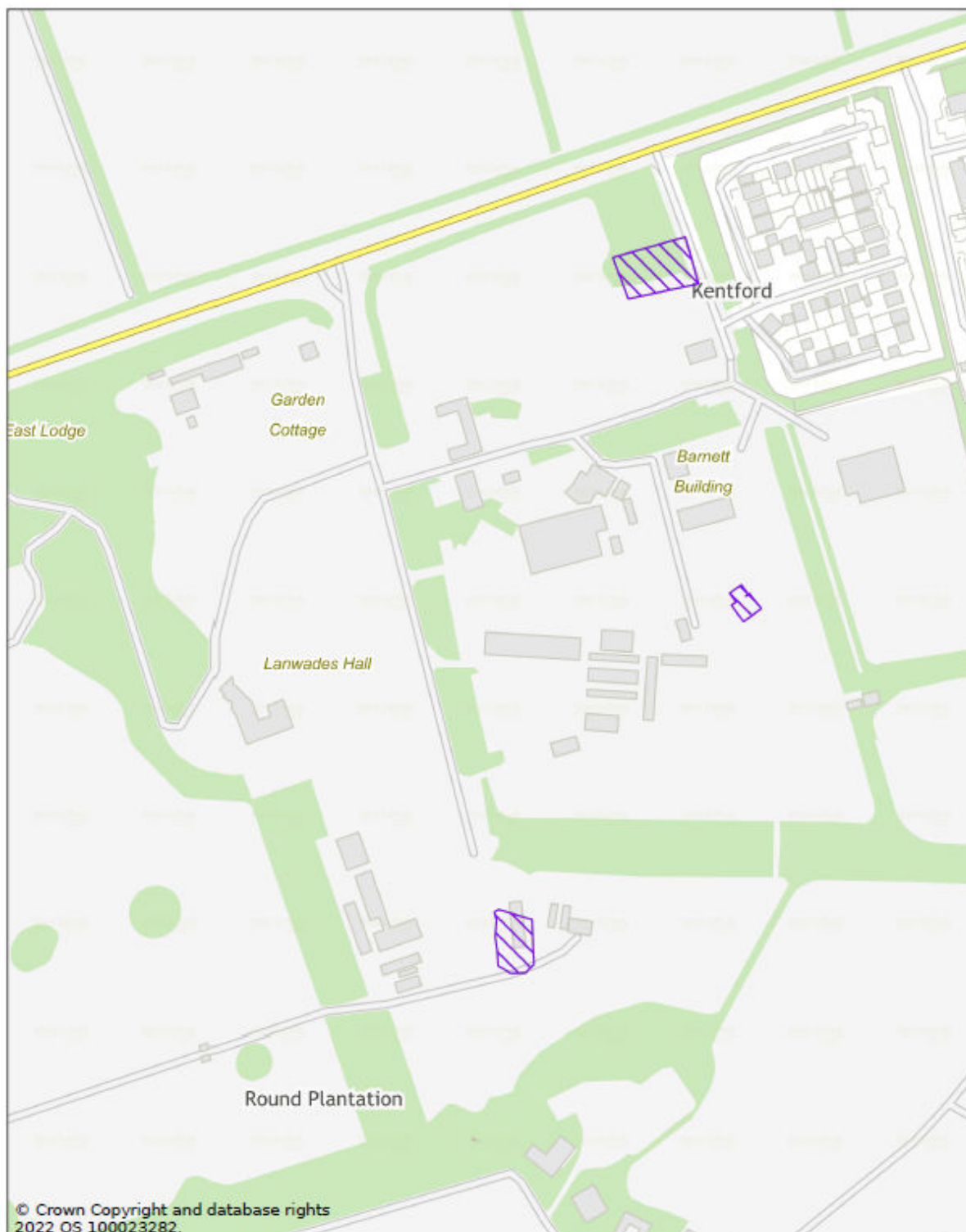
